

PERSONALITY INVENTORY USE AND SERVICE AGREEMENT

1. PARTIES

2. SUBJECT OF THE AGREEMENT

This Agreement determines the procedures and principles regarding the use of analysis, evaluation, and reporting services related to the CharacterIX Personality Inventory.

3. ROLE AND RESPONSIBILITY DEFINITION

CharacterIX is the system provider. The execution of consent processes is the responsibility of the Institution.

4. RIGHTS AND OBLIGATIONS OF CHARACTERIX

CharacterIX has the right to make necessary technical updates and changes to the system. Reports produced do not constitute medical diagnosis or clinical evaluation.

5. RIGHTS AND OBLIGATIONS OF THE INSTITUTION

The Institution is responsible for conducting necessary information and consent processes. For participants under the age of 18, obtaining parental consent is the responsibility of the Institution.

6. PERSONAL DATA PROTECTION AND CONFIDENTIALITY

The Parties agree to comply with applicable legislation regarding the protection of personal data. Confidentiality obligations shall continue for three (3) years after termination of the Agreement.

7. DATA RETENTION PERIOD

Personal data shall be retained for three (3) years following termination of the Agreement and shall thereafter be deleted, destroyed, or anonymized.

8. INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS

All content belonging to CharacterIX is protected under intellectual property rights.

8.1 BRAND AND PRESENTATION PROTECTION

The Institution shall not present CharacterIX reports as its own product or model and shall not create any website or system that may be confused with the CharacterIX brand.

9. FEES AND PAYMENT

Payment shall be made on a cash basis following the issuance of the invoice.

10. USAGE PACKAGES, VALIDITY PERIOD, NON-REFUND AND TRANSFER

Purchased usage rights shall be valid for three (3) years from the date of purchase. Unused rights shall expire at the end of this period. Usage rights are non-refundable. Unused usage rights may be transferred to another institution with the approval of CharacterIX.

11. TERM OF THE AGREEMENT

The term of the Agreement shall be three (3) years and may be renewed upon mutual agreement of the Parties.

12. TERMINATION

Either Party may terminate this Agreement by providing written notice at least thirty (30) days in advance.

13. LIABILITY

The Parties shall exercise due care in fulfilling their obligations under this Agreement.

14. DISPUTE RESOLUTION

In the event of disputes, the Courts and Enforcement Offices of Istanbul shall have jurisdiction.

15. FORCE MAJEURE

Neither Party shall be held liable for events beyond its control such as natural disasters, fire, epidemics, cyber-attacks, or infrastructure failures.

16. ELECTRONIC ACCEPTANCE

Approval given through the system shall have the same legal effect as a written signature.

17. RECORDING OF CONSENT

User consent records shall be stored in the system and may be used as legal evidence when necessary.

18. PERSONAL DATA PROCESSING PROTOCOL

The procedures and principles regarding personal data processing shall be regulated separately and carried out in compliance with applicable legislation.

19. ACCESS AND UPDATE OF THE AGREEMENT

Users may access this Agreement through the system at any time. CharacterIX may update this Agreement when necessary.

20. INFORMATION DOCUMENTS

The price list, data processing information, privacy notice, and consent procedures shall be made available to users through the CharacterIX website. These documents define the operational rules of the system and are binding in their current versions.
